WHAT IS A PRIMARY?

A primary is an election staged to choose the nominee of a political party. There are separate Republican and Democratic primaries with different ballots, but Reps and Dems vote at the same polling locations. The Dallas County Primary Election will be March 6, 2018. If no candidate in a race receives a majority, a Primary Runoff will be held between the top two vote-getters to determine who wins the nomination.

IS THIS THE RACE BETO NEEDS TO WIN?

No. Beto O'Rourke, who is a Democrat running against Ted Cruz in 2018, will easily win the nomination on March 6, even thought he has two opponents. He needs to win the midterm in November 2018 in order to beat Ted Cruz. However, he is still on the ballot for March 6 so vote for him then.

CAN I VOTE FOR BOTH REPUBLICANS AND DEMOCRATS IN A PRIMARY?

No. Primaries in Texas are primarily closed. This means that you can only vote in one. If you signed the ballot petition for any candidates, you are obligated to vote in the primary of the candidate whose ballot petition you signed.

IF I VOTE FOR DEMOCRATS IN THE PRIMARY CAN I CHANGE MY MIND IN THE GENERAL ELECTION?

Yes. You can also change your mind in the primary runoff, if one is necessary.

HOW DO I VOTE IF I AM NOT FAMILIAR WITH THE CANDIDATES?

DALLAS COUNTY DEMOCRATIC PARTY CHAIR

The last race on the ballot is for the Chair of the Dallas County Democratic Party. The incumbent, Carol Donovan, is being challenged by **Chris Hamilton**, who is well-known for his progressive work leading the defense of immigrants caught at DFW Airport after Trump's first travel ban. **Forward Motion Texas and Women of Dallas United for Action both recommend Chris**.

While this race does not get much attention, it is critical that we have strong, inspiring leadership for our local candidates. This race is not a primary – **the winner will be elected on March 6**.
















District Attorney

After Republican District Attorney Susan Hawk stepped down in 2016, Governor Gregg Abbott appointed current DA Faith Johnson to take her place. Ever since, Democrats have been preparing for a battle to retake the seat and regain control over how decisions are made regarding criminal prosecutions in Dallas County.

Both John Creuzot and Elizabeth Frizell have previously been elected to judicial positions in Dallas County. They are both running to take on Republican Faith Johnson in the General Election in November.

Sheriff

Marian Brown, Roy Williams, Jr., Eland J. Sigler

Marian Brown was appointed by the Dallas County Commissioners Court after Lupe Valdez resigned to run for governor. Her main opponent is Roy Williams, Jr., a long serving Constable (also an elected position). Two Republicans also filed in the GOP primary, so the winner will have an opponent in November.
